We, the undersigned ("we" or "us"), intend to discuss with and/or submit to Hawco Productions Inc. or its affiliates (collectively, "**Hawco Productions**") certain concepts, proposals and/or related materials created by us (collectively, whether currently or subsequently developed, the "**Material**"). We hereby jointly and severally acknowledge, represent, warrant and agree as follows:

1. We have the full right to submit the Material to Hawco Productions upon the terms and conditions stated in this agreement and the Material is completely original to us and does not infringe the rights of any third parties. We further represent and warrant that We are the sole and exclusive authors and owners of all rights in and to the Material.
2. Hawco Productions has not made any prior representations to us regarding the Material and shall not be under any obligation if the Material is not selected for development by Hawco Productions.
3. We have retained a copy of the Material, and we agree that Hawco Productions shall not have any obligation to return the Material, nor shall Hawco Productions have any obligation for loss or damage to any physical versions of the Material.
4. Our submission of the Material is voluntary and no fiduciary or employment relationship between Hawco Productions and us exists or is being created by this agreement or our submission of the Material.
5. We and Hawco Productions agree that Hawco Productions must secure our ongoing and meaningful involvement in order to use or rely upon any Material contemplating our direct participation in a television series or other audio-visual project. Notwithstanding the foregoing, we understand and agree that:
 - a) We shall not be entitled to any compensation for use by Hawco Productions of any materials similar to the Material if Hawco Productions received a prior similar submission, subsequent similar submission not based on the Materials, or independently created material based on an idea similar to which our submission is based; and
 - b) Hawco Productions may have independently developed ideas, program formats and literary and other materials, or may, after the time we submit the Material, develop ideas, program formats and literary and other materials which are identical or similar to the Material which we are submitting to Hawco Productions, and we agree that Hawco Productions will have the unrestricted right to use such identical or similar ideas, program formats and literary formats and other materials which Hawco Productions have independently developed and we will have no right or recourse against Hawco Productions in respect of such usage.
6. We shall maintain the confidentiality of any concepts, proposals and/or related materials disclosed by Hawco Productions to us in connection with our submitted Material. Hawco Productions shall maintain the confidentiality of our submitted Material, except that they may disclose such information as required by law or as they deem appropriate, in their sole discretion, in order to pitch, finance, develop, produce or promote any project involving the Material.
7. We hereby release Hawco Productions from (a) any and all claims, demands, costs, and liabilities that may arise in connection with or related to the Material, and/or (b) any claim now or hereafter made by us that Hawco Productions has used or appropriated the Material or any portion thereof.
8. In the event of a dispute concerning this agreement, our only remedy shall be to seek damages. In no event shall we be entitled to injunctive or other equitable relief.
9. The validity, interpretation and legal effect of this agreement shall be governed by the laws of the Province of Ontario.
10. This agreement is the entire agreement between us and Hawco Productions with respect to the subject matter hereof and cannot be modified or cancelled except by written instrument signed by each of us and Hawco Productions.
11. We have read the foregoing and fully understand the terms and conditions contained herein.
